If a renewal application is not received by that date, the applicant is required to cease practicing architecture on 31 December until such time as the Board has approved the renewal request.

Upon approval of the Board, the License fee will be pro-rated for a License Holder if s/he applies for Medical Disability, Family Leave, or other extenuating circumstances.
